PCUP BIDS AND AWARDS COMMITTEE RESOLUTION NO. 001-14

A RESOLUTION RECOMMENDING TO THE CHAIRMAN AND CHIEF EXECUTIVE OFFICER OF THE PRESIDENTIAL COMMISSION FOR THE URBAN POOR (PCUP) THE AWARD OF CONTRACT TO AND ENTER INTO A DEED OF ABSOLUTE SALE WITH TOYOTA COMMONWEALTH, INC. FOR THE SUPPLY AND DELIVERY OF MOTOR VEHICLES, TO WIT: ONE TOYOTA HI-ACE COMMUTER VAN AND ONE TOYOTA INNOVA J, DIESEL M/T, FOR OFFICAL USE OF THE COMMISSION, PURSUANT TO PHILIPPINE GOVERNMENT ELECTRONIC PROCUREMENT SYSTEM (PHILGEPS) PER SECTION 8 OF REPUBLIC ACT NO. 9184, OTHERWISE KNOWN AS THE GOVERNMENT PROCUREMENT REFORM ACT, AND ITS REVISED IMPLEMENTING RULES AND REGULATIONS AND IN ACCORDANCE WITH THE APPROVED BUDGET FOR THE CONTRACT (ABC) AS PROVIDED FOR IN THE GENERAL APPROPRIATIONS ACT (GAA) OF 2014.

WHEREAS, in order to facilitate professionalization and harmonization of procedures and standards as mandated by Section 11, Rule V of Revised IRR of Government Procurement Reform Act, the head of the procuring entity—the Chairman and Chief Executive Officer of the PCUP, had issued a Special Order No. 010-14 dated 3 February 2014 creating the Bids and Awards Committee (BAC) and the Secretariat, whose members met the qualifications provided for in Section 11.2.1, Rule V of the Revised IRR of Rep. Act 9184;

WHEREAS, the BAC commenced the performance of its functions, as provided for in Section 12, Revised IRR of the same Act, on 4 March 2014 and onward, for the purpose of purchasing two motor vehicles, namely one Toyota Hi-Ace Commuter Van and one Toyota Innova J, Diesel M/T for the official use of PCUP's Administrative and Finance Department and Field Operations Department for the National Capital Region;

WHEREAS, the following had submitted their bids:

WHEREAS, the bid of Toyota Commonwealth, Inc. has the lowest bid and most advantageous to the PCUP;

WHEREAS, upon compliance of the procedural and substantive aspects of Section 12 of the Act, such as advertising and/or posting the invitation to bid/request for expressions of interest; conduct pre-procurement and pre-bid conferences; determine the eligibility of prospective bidders; receive bids; conduct the evaluation of bids; undertake post-qualification proceedings; recommend award of contracts to the Head of the Procuring Entity; and performed such other related functions as may be necessary:

Resolved by the Bids and Awards Committee, To recommend to the Chairman and Chief Executive Officer of the **PRESIDENTIAL COMMISSION FOR THE URBAN POOR (PCUP)** the award of contract to and enter into a deed of absolute sale with **TOYOTA COMMONWEALTH, INC.** for the supply and delivery of motor vehicles, to wit: **ONE TOYOTA HI-ACE COMMUTER VAN AND ONE TOYOTA INNOVA J, DIESEL M/T**, for official use of the **COMMISSION**, pursuant to Philippine Government Electronic Procurement System (**PHILGEPS**) per Section 8 of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, and its Revised Implementing Rules and Regulations and in accordance with the Approved Budget for the Contract (**ABC**) as provided for in the General Appropriations Act (**GAA**) of 2014.




