

COMMISSION RESOLUTION NO. 02
Series of 2018

"A RESOLUTION CREATING A TECHNICAL WORKING GROUP FOR THE PURPOSE OF REVIEWING ON THE AMENDMENTS OF THE PRESIDENTIAL EXECUTIVE ORDER NO. 82, SERIES OF 1986 AS STRENGTHENED AND AMENDED BY EXECUTIVE ORDER NO. 69, SERIES OF 2012 OTHERWISE KNOWN AS AN ORDER STRENGTHENING THE PRESIDENTIAL COMMISSION FOR THE URBAN POOR AND APPROPRIATING FUNDS THEREOF"

WHEREAS, former President Benigno S. Aquino III signed Executive Order No. 69, series of 2012 Strengthening the Presidential Commission for the Urban Poor. The EO transferred PCUP to the Office of the President to effectively coordinate, formulate and evaluate policies and programs concerning the urban poor;

WHEREAS, the Executive Order No. 69, s. 2012 provides for the following strengthened functions of PCUP, to wit:

- a. To undertake social preparation activities related to asset reform, human development and basic social services, employment and livelihood, other programs of the government for the urban poor;
- b. To participate in policy discussions relating to the urban poor in board meetings of the HUDCC, Key Shelter Agencies (KSA), Local Housing Boards (LHB) or other similar bodies;
- c. To submit quarterly reports to the Office of the President, relative to the status of compliance with the provisions of EO 69 and the pertinent provision of the law governing eviction and demolition activities

WHEREAS, there is a need to review and amend the Executive Order No. 69, series of 2012 to ensure that is truly reflective of the needs, ideals, and aspirations of the Filipino people especially the Informal Settler Families and to ensure that the mandate of the people, as expressed thereon, is responsive to the changing times;

RESOLVED AS IT IS HEREBY RESOLVED, for and consideration of the foregoing, we, the Members of the Commission, by virtue of the powers vested on us by law, do hereby resolved to adopt and approve the creation of **TECHNICAL WORKING GROUP FOR THE PURPOSE OF REVIEWING ON THE AMENDMENTS OF THE PRESIDENTIAL EXECUTIVE ORDER NO. 69, SERIES OF 2012 OTHERWISE KNOWN AS AN ORDER STRENGTHENING THE PRESIDENTIAL COMMISSION FOR THE URBAN POOR AND APPROPRIATING FUNDS THEREOF**, with the following provisions, to wit:

SECTION I: OBJECTIVE.

The Presidential Commission for the Urban Poor which mandated by law under Executive Order No.82 as amended and strengthened by Executive Order No. 69, s. 2012 which mandated to review existing legislations, policies and programs of the government relating to the urban poor, in consultation with the latter, and recommend appropriate actions thereon to the President.

SECTION II. THE CREATION OF TECHNICAL WORKING GROUP AND ITS COMPOSITION

There shall be a Technical Working Group, which shall study, conduct consultation, and review the provisions of the Executive Order No. 69, s. 2012, but not limited to, the provisions on the structure and powers of the government and economic policies. The TWG shall compose of the following:

SECTION III: INTERNAL RULES AND REGULATIONS

The TWG shall formulate and adopt its internal rules and procedure in conducting the study, review and consultations on the provisions of the Executive Order No.82 as amended and strengthened by Executive Order No. 69, s. 2012 within fifteen (15) working days from the date it is convened.

SECTION IV: SECRETARIAT AND ITS FUNCTIONS

The Office of the Commissioner Norman B. Baloro will act as its Secretariat and designated staff of the office will be appointed as the Head of the Secretariat.

1. It is primarily the responsibility of the Secretariat to provide the output of the TWG and records keeping of the documents
2. The secretariat will be assisted by four (4) employees/staff of the Commission
3. The Secretariat will submit reports to the members of the TWG

SECTION V. COMPLETION

The TWG shall endeavor to complete its work on or before the lapse of six (6) months from the date it is convened. After its presentation to the Chairperson and CEO of its report, recommendations and proposal, the TWG shall wind up its operations.

Upon the Chairperson and CEO's transmittal of the Commission on Secretary recommendations and proposals to the Cabinet Secretary.

SECTION VI: FUNDING AND OTHER ADMINISTRATIVE REQUIREMENTS

The funding and other administrative requirements of the Technical Working Group (TWG) will be incurred in the regular budget of the Commission.


SECTION VII. ADOPTION
