



COMMISSION RESOLUTION NO. 010

"A RESOLUTION SEEKING PRESIDENTIAL INTERCESSION FOR THE ISSUANCE OF AN EXECUTIVE ORDER DIRECTING ALL NATIONAL GOVERNMENT AGENCIES (NGAS) IMPLEMENTING PROGRAMS, PROJECTS AND ACTIVITIES (PPAS) AFFECTING URBAN AND RURAL POOR COMMUNITIES TO COORDINATE WITH THE PRESIDENTIAL COMMISSION FOR THE URBAN POOR (PCUP) WHICH SHALL TAKE THE LEAD IN THE CONDUCT OF ALL SOCIAL PREPARATION ACTIVITIES RELATED TO PPAS IN ORDER TO ENSURE COMPLIANCE WITH SECTION 28 OF THE REPUBLIC ACT NO. 7279 OTHERWISE KNOWN AS URBAN DEVELOPMENT AND HOUSING ACT OF 1992"

WHEREAS, Executive Order No. 82 dated 8 December 1986 created the Presidential Commission for the Urban Poor to coordinate the various activities and services being rendered by government and non-government organizations for the urban poor;

WHEREAS, the Presidential Commission for the Urban Poor (PCUP) reiterating the Administrative Order (AO) No. 111, s. 1989, that directs all government department, agencies and offices concerned to coordinate with the PCUP in the planning, implementation and evaluation of their respective programs and projects for the Urban Poor;

WHEREAS, Executive Order No. 69 dated March 29, 2012, specifically for PCUP to conduct Social Preparation Activities related to asset reform, human development and basic social services, employment and livelihood, and other programs of the government for the urban poor;

WHEREAS, there is a need for concerted and coordinated effort of all sectors concerned to fully address the concerns of the urban poor;

WHEREAS, Presidential Commission for the Urban Poor undertakes social preparation activities related to asset reform, human development and basic social services, employment and livelihood and other programs of the government for the urban poor;

WHEREAS, Social Preparation refers to the series of activities designed to prepare the affected families to cope with the changes brought about by government infrastructure or development projects;

RESOLVED AS IT IS HEREBY RESOLVED, to seek Presidential Intercession for the Issuance of an Executive Order Directing all National Government Agencies (NGAs) implementing programs, projects and activities (PPAs) affecting urban and rural poor to Coordinate with the Presidential Commission for the Urban Poor (PCUP) which shall take the lead in the conduct of all Social Preparation Activities related to PPAs in order to ensure compliance with Section 28 of the Republic Act No. 7279 otherwise known as Urban Development and Housing Act of 1992", with the following provisions:

SECTION I. COVERAGE. This resolution specifies the set of initial activities of all National Government Agencies implementing National Government Programs that should be conducted prior to the implementation on asset reform, human development and basic social services, employment and livelihood for the benefit of the affected families.

SECTION II. OBJECTIVES. This resolution intends to:

- a. Prepare and set the tone for the social transformation of the underprivileged and homeless families as regards the program or project that will be implemented;
- b. Encourage participation of affected families from the preparation and planning to the final stage of the program or project;
- c. Empower and develop the underprivileged and homeless families as partners in the community's development process which geared towards comprehensive community development; and
- d. Establish sustainable mechanism through consolidation and assessment integrating the inputs of the affected families.

SECTION III. COORDINATION WITH THE DIVISIONS AND OTHER UNITS AND TIMELINE

- a. *Month of July* – the Office of the Commissioner-Proponent will coordinate with Field Operations Division, Research, Planning, Monitoring and Development Division and Office of the Chairperson to draft the Executive Order in Compliance of Memorandum Circular No. 68, s. 2004 on Complete Staff Work (Office of the Executive Secretary) Office of the President.
- b. *Month of August* – Inter-agency Meeting with National Government Agencies/Department on the Draft Executive Order thru the help of Office of the Cabinet Secretary
- c. *Month of September* – Submission to the Office of the President thru Executive Secretary for the Approval of the President


If in case there shall be revision of the Proposed Executive Order, there will be a Follow-up Inter-agency Meeting for the finality of the document.

SECTION IV: FUNDING AND OTHER ADMINISTRATIVE REQUIREMENTS

The funding and other administrative requirements of this resolution will be incurred in the regular budget of the Commission subject to the existing government accounting, budgeting and auditing Rules and Regulations.
