COMMISSION RESOLUTION NO. 04

“A RESOLUTION AUTHORIZING CHAIRPERSON/CEO ALVIN S. FELICIANO TO SIGN ALL MEMORANDUM OF AGREEMENT/UNDERSTANDING PERTAINING TO THE IMPLEMENTATION OF NATIONWIDE PCUP CARAVAN”

WHEREAS, by virtue of Executive Order No. 82 dated 08 December 1986 and as strengthened by Executive Order No. 69 dated 29 March 2012, PCUP serves as a direct link of the urban poor to the government in policy formulation and program implementation addressed to their needs;

WHEREAS, one of the 10-Point Socio Economic Agenda of the Duterte Administration is to invest in human capital development, including health and education systems and match skills and training to meet the demand of business and the private sector;

WHEREAS, the Philippine Development Plan 2017-2022 stated that Filipino people primarily the urban poor wish to enjoy a “matatag, maginhawa at panatag na buhay” as well as maintain a comfortable life with affordable house and security of tenure including livelihood and employment opportunities which are all part of AmBisyonNatin 2040 development agenda;

WHEREAS, the Commission is persistently pursuing to implement the program priorities for 2018-2022 entitled #PCUP at your Service with three (3) major components namely: the PCUP Caravan: “Pinagsama-samang Serbisyo Para sa Tao,” Adopt an Urban Poor Community and the PCUP Urban Poor Privilege Card;

WHEREAS, the PCUP thru Commission Resolution No. 22 support and approve the adoption of the three (3) priority programs for the year 2018-2022; and

WHEREAS, PCUP will enter into Memorandum of Agreement with the different National Government Agencies, the Private Sector and the NGOs to institutionalize the partnership between the agencies/entities providing the services for the urban poor thru the nationwide PCUP Caravan Project: “Pinagsama-samang Serbisyo Para sa Tao”.

NOW THEREFORE, be resolved, as it is hereby resolved, a resolution authorizing Chairperson/CEO Alvin S. Feliciano to sign all Memorandum of Agreement/Understanding pertaining to the implementation of Nationwide PCUP Caravan to authorize Chairperson/CEO Alvin S. Feliciano to enter with all Memorandum of Agreement/Understanding pertaining to institutionalizing partnership between PCUP and Partner Agencies for the implementation of Nationwide PCUP Caravan.
