"A RESOLUTION ENDORSING THE AMENDMENT OF THE IMPLEMENTING RULES AND REGULATIONS GOVERNING THE MEMORANDUM OF AGREEMENT ON THE DISBURSEMENT OF THE 2015 INTERIM SHELTER FUND AND AUTHORIZING PCUP CHAIRPERSON ALVIN SAN JUAN FELICIANO AND COMMISSIONER RANDY H. HALASAN TO SIGN FOR AND IN BEHALF OF PCUP PURSUANT TO THE AMENDMENTS"

WHEREAS, Presidential Commission for the Urban Poor and Department of Interior and Local Government entered into a memorandum of agreement dated December 05, 2016 on the disbursement of the 2015 Interim Shelter Fund; and

WHEREAS, Pursuant to Section 2, Executive Order No. 69 s. 2012, the Presidential Commission for the Urban Poor shall undertake social preparation activities related to asset reform, human development and basic social services, employment and livelihood, and other programs of the government for the urban poor.

RESOLVED AS IT IS HEREBY RESOLVED, for and in consideration of the foregoing, we, the Members of the Commission, by virtue of the powers vested on us by law, do hereby resolved the resolution for the support of the **PROPOSED AMENDMENT OF THE IMPLEMENTING RULES AND REGULATIONS GOVERNING THE MEMORANDUM OF AGREEMENT ON THE DISBURSEMENT OF THE 2015 INTERIM SHELTER FUND**, with the following provisions, to wit:

Chapter III. Section 7. Validation Requirements

xxx

- (4) In case of ISFs who availed of the LGU-Initiated, People Plan Fund Program (PPFP) and Social Housing Financial Corporation (SHFC) housing programs, the ISF claimant should present the following, in addition to requirements (1) and (2):
- a) NHA/LGU, UPAO or the equivalent Housing Office Certification that the said ISF claimant previously resided on top, along or within the three-meter legal easements of the Priority waterway.
 - b) For people's plan enrolled under the HDH Program of the SHFC, a Certification that the ISF claimant is a Member-beneficiary/enrolled in a particular People's Plans.
 - c) For non-approved people's plans, Certification of dismantling from UPAO or equivalent office.

Chapter V. Section 11. Disbursement Requirements


XXX

- (4) In case of ISFs who will availed the LGU-Initiated, PPF and SGHC Housing programs, the ISF claimant should present the following in additional to requirements (1) and (2):
- a) NHA/LGU, UPAO or the equivalent Housing Office Certification that the said ISF claimant previously resided on top, along or within the three-meter legal easements of the Priority waterway.
 - b) For people’s plan enrolled under the HDH Program of the SHFC, a Certification that the ISF claimant is a member-beneficiary/enrolled in a particular People’s Plans.
 - c) For non-approved people’s plans, Certification of dismantling from UPAO or equivalent office.
