COMMISSION RESOLUTION NO. 08-2019

A RESOLUTION RE-ORGANIZING AND RE-CLUSTERING THE COMMITTEES OF THE PRESIDENTIAL COMMISSION FOR THE URBAN POOR (PCUP) AND PROVIDING FUNDS THEREFOR

WHEREAS, upon motion, the Commission decided to amend and reclassify the composition of the Consolidated Sub-Committees referred to in Special Order No. 197.18 dated June 25, 2018;

WHEREAS, the reclassification of the Committees by the *Commission En Banc* serves to enhance the effectivity of work in the PCUP and to help improve the efficiency of the Commission in terms of policy making, legislation and implementation;

WHEREAS, the proposed reclassification of Committees has been presented to the *En Banc* Members during the 2nd Regular Commission Meeting dated September 26, 2019 and subsequently deliberated and approved;

WHEREAS, the new Committees shall be headed and supervised by each Commissioner;

NOW THEREFORE, the Commission resolves, as it is hereby resolved, to adopt the new list of Commission Committees with the following Committee heads:

SECTION 1. PURPOSE. This resolution is issued in accordance with the Internal Rules and Procedure of the Commission *En Banc* of the PRESIDENTIAL COMMISSION FOR THE URBAN POOR (PCUP), and shall:

- (a) Conduct complete staff work (CSW) on the proposed policies, resolutions and other measures;
- (b) Coordinate with Field Operations and other concerned units for the validation, further assessment, review and discussion on the proposed policies; and
- (c) Submit a Committee Report to the Commission *En Banc* for the Approval of the policies, resolutions and other measures.

SECTION 5. MEETINGS. The assigned committees shall meet regularly to discuss the proposed policies, resolutions and other measures.

SECTION 6. FUNDING AND OTHER ADMINISTRATIVE REQUIREMENTS. The funding and other administrative requirements of this resolution will be incurred in the regular budget of the Commission.
