A RESOLUTION AUTHORIZING CHAIRPERSON/CEO ALVIN S. FELICIANO TO SIGN THE JOINT MEMORANDUM CIRCULAR (JMC) NO. 01 SERIES 2020 RELATIVE TO THE GUIDELINES FOR THE IMPLEMENTATION OF EXECUTIVE ORDER NO. 67, SERIES OF 2018, PARTICULARLY SECTION 01 THEREOF

WHEREAS, by virtue of Executive Order No. 82 dated 08 December 1986 and as strengthened by Executive Order No. 69 dated 29 March 2012, the PCUP serves as a direct link of the Urban Poor to the government in policy formulation and program implementation addressed to their needs;

WHEREAS, Section 1 (c) of Executive Order No. 67 dated 31 October 2018 entitled "Rationalizing the Office of the President through the Consolidation of its Core Mandates and Strengthening the Democratic and Institutional Framework of the Executive Department (EO2018-067)" which provides the transfer of supervision of the agencies under or attached to the Office of the President which includes the National Anti-Poverty Commission, National Commission on Indigenous People and the Presidential Commission for the Urban Poor to the Department of Social Welfare and Development (DSWD);

WHEREAS, the transfer shall harmonize their policies and activities with the supervising Department and simplify systems and policies to ensure effective and responsive delivery of services in the attainment of the Administration's ten-point socio-economic agenda; and

WHEREAS, the PCUP, the NAPC, and the NCIP will enter into an agreement in the form of a Joint Memorandum Circular with the Department of Social Welfare and Development as the supervising Department.

NOW THEREFORE, for and in consideration of the foregoing, we, the Members of the Commission *En Banc*, by virtue of the powers vested in us by law, do hereby resolve to authorize Chairperson/CEO Alvin S. Feliciano to sign the Joint Memorandum Circular No. 01, Series of 2020 in reference to the implementation of Section 1 (c) of Executive Order No. 67 dated 31 October 2018 to institutionalize the partnership of the PCUP with the aforesaid national agencies.
